Corner solves all of these issues and more! Our cryptographic coding ensures that only the end user of your communication receives the message, picture, phone call, or file. No more, do you need to worry about who is looking at your private conversations or files.

Corner will allow for voice, video, and file sharing on the web, android, or IOS systems, for free. Corner can be used locally, nationally or internationally once the software is downloaded. Corner, can be used both on Wi-Fi and with the data.

Users accounts will sign up with a phone number. Once logged in you can setup a password. In addition to a username and password, you can setup PIN's on your phone or login via biometric authentication already on your device. You will also have the ability to set a "Timeout" limit on each device that you have Corner downloaded to, for further protection.

Additional features include having the ability to set a timer that would delete messages from both the senders and the receivers devices ranging from a few seconds to a few days. There will also be read receipts and typing indicators, but these features can be turned on and off in settings as the user deems fit.

Software encryption will be based on XEdDSA and VXEdDSA, X3DH, Double Ratchet, Sesame.
